## Release and Indemnification

In consideration for being allowed to participate in the Savannah Harbor Foundation's 18th Annual Boat Parade of Lights, each participant agrees and contracts to release, indemnify and hold harmless Savannah Harbor Foundation inc., Clearview Hotel Captial LLC d/b/a The Westin Savannah Harbor Golf Resort & Spa (collectively referred to as "The Westin Savannah Harbor Resort"), including its agents, officers, directors, employees, representatives and related entities, collectively or individually, including indemnity for any negligent acts or omissions of the fore-going released and indemnified parties, from any and all liability, claims, or damage arising out of or in any manner whatsoever connected with The Westin Savannah Harbor Resort's planning, operation or conduct of the Savannah Harbor Foundation's 19th Annual Boat Parade of Lights, including, but not limited to, claims for personal injury, wrongful death, survival damages, or property damage, whether sustained by the participant, the participants servants, employees, or guests. Each participant further agrees to indemnify and hold harmless The Westin Savannah Harbor Resort, including its agents, officers, directors, employees, representatives and related entities, collectively or individually, from any expense, loss, property damage, personal injury, claim or liability caused by the participant, the participant's servants, employees or guests. The participants shall be fully responsible for his/her vessel and guests at all times. Boat toilets shall not be used while the boat is docked, unless the boat is equipped with an operating holding tank, so that no effluent is discharged into the Savannah River.

## Arbitration Provision

Any controversy, claim or dispute arising out of or in any way relating to the Savannah Harbor Foundation's 18th Annual Boat Parade of Lights shall be settled by binding arbitration conducted in Savannah, Georgia, in accordance with the commercial arbitration rules of the American Arbitration Association. Judgment on the award rendered by the arbitrator may be entered by a court of competent jurisdiction in accordance with the law. Should litigation and/or arbitration result between a participant and The Westin Savannah Harbor Golf Resort & Spa, it is agreed that the prevailing party in such litigation and/or arbitration shall be entitled to recover reason-able attorney's fees and all costs from the other party.
